

The Tutt Family in America

The first Tutt in America is not known with certainty. A large number of Tutts still live in Wiltshire, Hampshire, Sussex and Kent in England. Some Tutt family traditions maintain that they came from Wiltshire, but no proof has been discovered. Kew Records Office in London (Passage and Immigration List) show a Robert Tutt coming to Maryland in 1649 and a John Tutt "and 7 others" (Shippers from the Hopewell) coming to Virginia in 1864. There is also the possibility that some Tutts were "transported" by court order from England to the New World. After the Monmouth's Rebellion (1685) against James II, two Tutts were tried by "Hanging Judge Jeffries" and, unusually, not hung. Most of our current research efforts are directed two ways: first, to link all the Tutts within America, which includes both English decent and a large number of Afro-Americans, and second, to trace the Virginia line of Tutts from Richard (1) back to England. We start with Richard (1) and not John, because he is the first continuous link we can currently document for our family in America.
